
I am to state that the General Body of the Council at its meeting held on 21st & 22nd June, 2001 considered the Council Inspector's report (March, 2001) on the standard of examination and other teaching facilities available at Christian Medical College, Vellore for purpose of approval of the college for the award of M.D.(Pathology) & D.C.P. qualifications earlier granted by Madras University and now by The Tamilnadu Dr. M.G.R.
