

In exercise of the powers conferred by Sections 25(i) and 35(4) of NMC Act, 2019, the approval of PGMEB, NMC is hereby conveyed for grant of **Recognition against increased intake of 01 to 02 seats & Renewal of Recognition of 01 seat of M.Ch.(Vascular Surgery) qualification in respect of students being trained at Christian Medical College, Vellore under The Tamil Nadu Dr. M.G.R. Medical University, Chennai**, under the following terms and conditions, as contained in the Post Graduate Medical Education Regulations, 2000:
